ARMY CORPS OF ENGINEERS

Victor A. Landry III (Vic) is currently the Gulf Intracoastal Waterway (GIWW) and Bonnet Carre' Spillway Operations Manager, Operations Division at the New Orleans District, Corps of Engineers.

After graduating from the University of Louisiana at Lafayette in 1991, Vic began his professional career in Lafayette with a small A/E firm. Vic returned to New Orleans where he worked for a local A/E as a project manager and construction manager both designing and overseeing large private and public sector projects.

Mr. Landry was selected for this position in May 2007. As the GIWW Operations Manager, he is responsible for directing the operation and maintenance of the GIWW shallow draft waterway, 6 locks, and the Bonnet Carre' Spillway. There are 96 employees that comprise the GIWW team. He is also the Operations Division representative for the District EOC.

Team New Orleans provides comprehensive water resources management to include navigation, hurricane and storm damage risk reduction and environmental stewardship for south Louisiana to ensure public safety and benefit the nation.
